Facilities for Water conservation

i. Rain water harvesting

Rain water harvesting is a system which includes the collection and storage of rain water to increase the underground level of water. The college has implemented the Rain Water harvesting system. The rain water falling on the terrace is collected through pipes then it is collected in tank and is used for increasing the underground water level.

ii. Construction of tanks

Keeping in view the water conservation and efficient utilization of water, water tanks have been constructed. All the pumps have automatic ON/OFF systems to avoid wastage/ shortage of water. Water is obtained from different sources and then purified. For drinking water, a purification system like the RO plant is already in place. Water is distributed through pipe network in college. In order to avoid loss due to leakage, maintenance of water bodies and distribution system is carried out periodically.
